### PURPOSE OF THE JOB

The job holder is responsible for supporting AIF site operations with respect to Safety health and environment with the aim of an injury free site and ensuring all lifesaving rules are strictly adhered to with training and enforcement in every shift to control unsafe behaviors.

## TASKS & RESPONSIBILITIES

- Uphold the AIF SHE Management system in line with the DSM coherent SHE requirements on each shift.
- Develop shift SHE annual plan and present to line manager with monthly actions for follow up.
- Lead the Operational SHE team (SHE reps) in the shift and ensure all SHE issues are discussed and implemented on a regular basis.
- Prevent injury and illness to employees and assist AIF to comply with statutory safety health and environmental laws.
- Lead daily SHE tour and inspect the workplace to identify unsafe condition and unsafe acts and follow up with action owners to close all open actions.
- Support in the improvement of workers occupational health through monitoring of air quality, noise reduction and dust reduction.
- Ensure waste materials are collected and disposed appropriately with records.
- Monitor the usage of work permits issued for each high-risk job and report to SHE Manager on the performance weekly.
- Support all projects on site and follow up with contractors to fully comply with SHE
- Regularly inspect all SHE critical equipment and maintain records of calibration and service.
- Coordinate planned emergency drill with the SHE team, Security and Factory Nurse.
- Ensure pest is well managed everywhere on site and follow up with the IPM technician with monthly IPM reports.
- Ensure all SHE SOPs are reviewed and updated from time to time to reflect safety and LSR.
- Investigate and report accidents and near misses on site and take part in RCAs.
- Plan and conduct regular SHE tours and daily SHE inspections and close out.
- Take the lead in accident investigation and ensure all incidents are reported on time.
- Support shift leaders in identifying hazards and follow up in the correction and RCA where needed for incidents.

• Bachelor's degree in sciences, engineering, environmental sciences, or any other related field.



- A minimum of 3 years' experience in occupational or process Safety and Environment, preferably in food and/or beverage industry
